## **Monitoring Licence Notification CPI Adjustment of the Monitoring & YourPlay Fees**

### **Monitoring Fees**

#### **Core Monitoring Fee, Linked Jackpot Services Fee and Jackpot Financial Services Fee**

Consistent with clause 12.6 of the Venue Monitoring Services Agreement, the Monitoring Fees payable to Intralot Gaming Services Pty Ltd (**IGS**) are annually adjusted to Consumer Price Index movements every year on 16 August. The adjustment date is referred to as the **Fee Adjustment Date** in your Venue Monitoring Services Agreement.

For the purposes of calculating the **CPI Adjustment** (as defined in clause 1.1 of the Venue Monitoring Services Agreement), the **Consumer Price Index (All Groups) for the City of Melbourne** published by the Australian Bureau of Statistics for the 30 June 2016 quarter is **108.6** and the CPIX number (for the 30 June 2015 quarter) is **107.1**. This means a percentage increase in the Core Monitoring Fee, Linked Jackpot Services Fee and Jackpot Financial Services Fee of **1.4%** from 16 August 2016.

### **YourPlay Fee**

#### **Pricing Review Adjustment**

On each Fee Adjustment Date (16 August each year), the YourPlay Fee is subject to a pricing review in accordance with clause 16.3 of the Pre-Commitment Related Agreement. Following the application of clause 16.3 the YourPlay Fee per month will reduce from **\$22.66** to **\$22.57** excluding GST from 16 August 2016.

#### **CPI Adjustment**

Following the Pricing Review Adjustment, the YourPlay Fee is subject to a CPI Adjustment in accordance with clause 16.1(d) of the Pre-Commitment Related Agreement. For the purposes of calculating the **CPI Adjustment**, the **Consumer Price Index (All Groups) for the City of Melbourne** published by the Australian Bureau of Statistics for the 30 June 2016 quarter is **108.6** and the CPIX number (for the 30 September 2015 quarter) is **107.6**. This means a percentage increase in the YourPlay Fee of **0.9%** from 16 August 2016.
